OF 26TH FEBRUARY 2014

ON THE COMPOSITION OF THE SAFETY STANDARDS CONSULTATIVE COMMITTEE

REPEALING DECISION N° 2013/014/R N° ON THE COMPOSITION OF THE SAFETY STANDARDS CONSULTATIVE COMMITTEE OF 25 JULY 2013

THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Decision 01/2012 of the EASA Management Board of 13 March 2012 concerning the procedure to be applied by the Agency for the issuing of opinions, certification specifications and guidance material ('rulemaking procedure'), in particular Article 9 thereof, requiring the Executive Director to establish a Safety Standards Consultative Committee,

Having regard to changes in the membership of the Safety Standards Consultative Committee, hereinafter referred to as SSCC,

WHEREAS:

- (1) The SSCC group composition and that of its subcommittees, as set down in the ED Decision 2013/014/R, underwent changes in the course of the implementation of the revision of the SSCC.
- (2) The SSCC is composed of: a plenary group: the SSCC, whose members come from Industry organisations, and six subcommittees: namely the Aerodromes, Air Traffic Management/Air Navigation Services, Design and Manufacturing, Engineering and Maintenance, Flight Standards and General Aviation subcommittees, whose members come from Industry organisations and companies.
- (3) According to the SSCC Rules of Procedure, the Executive Director is entitled to appoint the representatives from all regulated parties as members of both the plenary SSCC and its subcommittees.
