DECISION NO 2011/017/R OF THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY

acceptable means of compliance and guidance material to Section 2 of Annex I to Commission Regulation (EU) No 691/2010 laying down a performance scheme for air navigation services and network functions as amended by Commission Implementing Regulation (EU) No 1216/2011

'Acceptable Means of Compliance and Guidance Material for the implementation and measurement of safety KPIs (ATM performance IR)' THE EXECUTIVE DIRECTOR OF THE EUROPEAN AVIATION SAFETY AGENCY,

Having regard to Regulation (EC) No 216/2008¹ (hereafter referred to as the 'Basic Regulation'), and in particular Article 38(3)(a) and (e) thereof,

Having regard to Commission Regulation (EU) No $691/2010^2$ (hereafter referred to as the 'performance scheme regulation') as amended by the Commission Implementing Regulation (EU) No 1216/2011, and in particular point 1(e) of Section 2 to Annex I.

Whereas:

- (1) Pursuant to point 1(e) of Section 2 of Annex I to the performance scheme regulation, the Agency shall adopt Acceptable Means of Compliance and Guidance Material to facilitate the implementation and measurement of the safety key performance indicators (KPIs).
- (2) The Agency shall, pursuant to Article 18 of the Basic Regulation, issue Certification Specifications, including Airworthiness Codes and Acceptable Means of Compliance, as well as Guidance Material for the application of the Basic Regulation and its Implementing Rules.
- (3) Pursuant to Article 19 of the Basic Regulation, Certification Specifications, Acceptable Means of Compliance and Guidance Material adopted by the Agency shall reflect the state of the art and the best practices in the fields concerned and shall be updated taking into account worldwide experience from in-service aircraft, as well as scientific and technical progress.
- (4) The Agency has consulted the PRB and, pursuant to Article 52(1)(c) of the Basic Regulation and Articles 5(3) and 6 of the Rulemaking Procedure³, has widely consulted the interested parties on the matters which are the subject of this Decision and has provided thereafter a written response to the comments received⁴,

HAS DECIDED:

Article 1

- 1. Acceptable Means of Compliance and Guidance Material for the implementation and measurement of safety KPIs pursuant to the performance scheme Regulation are established in the Annex to this Decision.
- 2. This Decision is applicable to Member States, their competent authorities and certified ATS and/or CNS providers subject to the performance scheme regulation.

Article 2

This Decision shall enter into force on 23rd December 2011. It shall be published in the Official Publications of the Agency.
