Panel 2: Regulatory process

This panel will discuss the current activities carried at EASA, in coordination with the European Strategic Coordination Platform (ESCP), in order to introduce a strong and flexible cybersecurity regulatory system for all aviation domains. It will also discuss the challenges created by the need to ensure consistency between these activities, the implementation of the NIS Directive (EU) 2016/1148 by the Member States and the ongoing amendments being discussed to align the aviation security Regulation (EU) No 2015/1998 with the latest amendments of Annex 17 to the Chicago Convention. In particular, it will pay particular attention to the importance for the Member States to clearly define who will be the competent authority for the cybersecurity elements applicable to aviation organisations, ensuring appropriate coordination at national level between the authorities responsible for safety and security.
